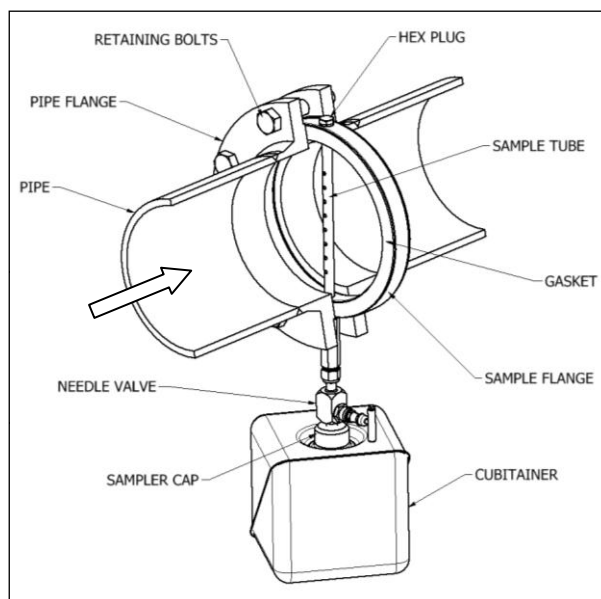

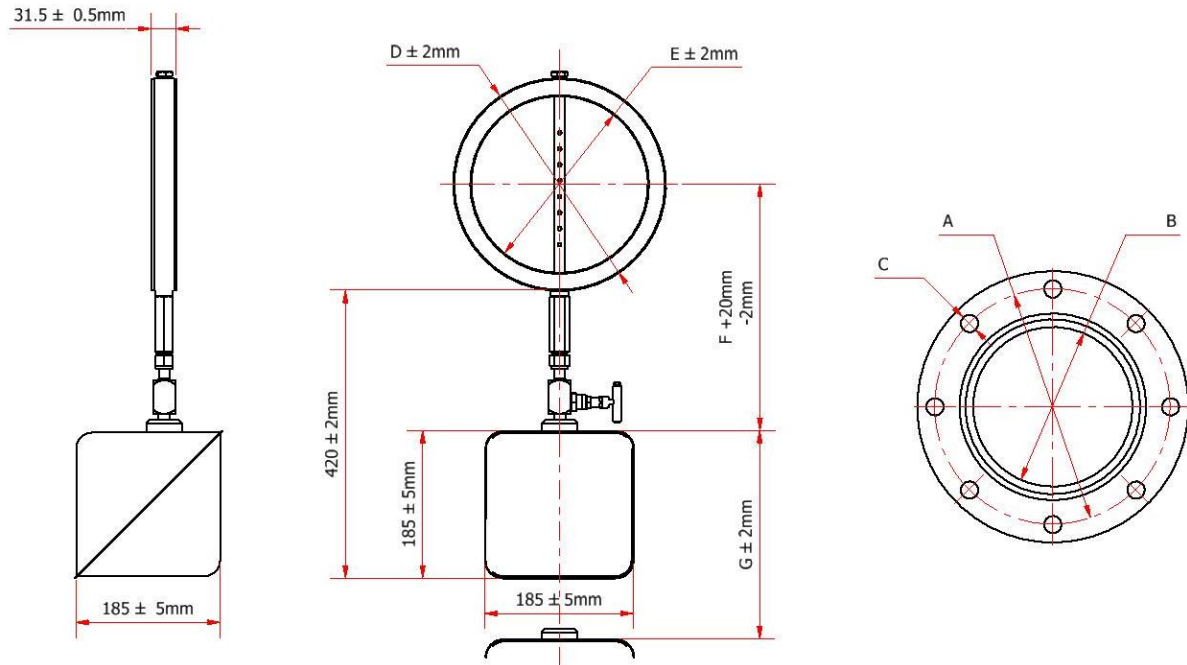

6. Bunker Sampling Accessories

Fuel Sampler / FG-K11079-WA (1-off)

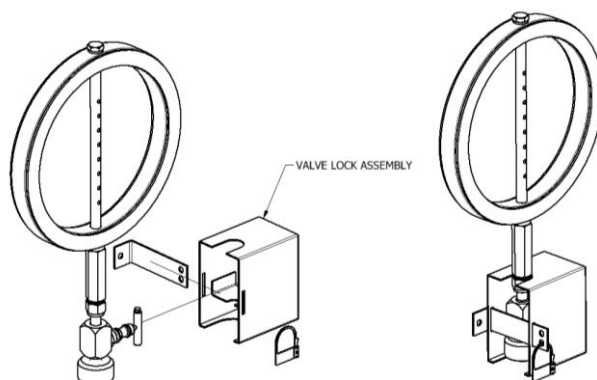
The fuel sampler is designed to fit (via a threaded boss) into an existing fuel supply line and can be removed with the fuel line full. Supplied in a single size, it can be modified to fit fuel delivery lines between 3 and 12 inches.

Cubitainers / FG-K3-201-KW (24-off)

Drip samplers use disposable 'Cubitainers' to collect fuel samples prior to mixing and transfer to sample bottles.

Valve Lock / FG-K1-139-KW (1-off)

A Valve Lock assembly is available to prevent sample tampering and to ensure the flow rate is maintained during sampling.



Converter Bobbin / FG-K3-021-KW (1-off)

A Converter Bobbin is available to allow DNVPS Samplers to use Parker Kittiwake Cubitainers.

Sampler Gauge / FG-K11168-KW (1-off)

With the Sampler Gauge fitted the user can observe line pressure during fuel transfer.

Elbow Kit for 45° Elbow / FG-K13588-KW

Kit to enable Sample Tube to be positioned at 45° with respect to the vertical.

Elbow Kit for 90° Elbow / FG-K13589-KW

Kit to enable Sample Tube to be positioned at 90° with respect to the vertical.

Bunker Sampler Plug and Lanyard / FG-K16692-KW

To prevent excess fuel discharging from the Bunker sampler during Cubitainer changes, a sampler plug can be fitted.

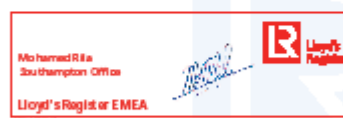
